

Appendix: Who Gets Retirement Plans and Why

The September 2008 issue of *Perspective* examines the various factors that lead some workers to favor compensation that includes both cash and retirement benefits more than cash alone, and the factors that lead some employers to choose to offer compensation that includes retirement benefits. This appendix provides supplementary tables with additional detail for the *September 2008 Perspective*.

Figure A1 tabulates households' most important reason for savings by groupings of households not tabulated in Figure 1. Figure A2 presents statistics on workforce composition and retirement plan coverage that are charted in Figure 7 through Figure 12 of the *Perspective*, as well as additional information not charted in the main paper. Statistics on workforce composition by firm size and employer sponsorship status that is charted in Figure 15 through Figure 18 is reported in Figure A3.

Additional information on workforce composition by worker characteristics not included in Figure 15 through Figure 18 is also reported in Figure A3. Figures A4 and A5 illustrate the derivation of the data presented in Figure 19. Figure A6 gives additional information on employer sponsorship and participation using the same categories of workers presented in Figure A5.
